Final allocations may vary based on final award amount and allocation data received from ED, and after required adjustments are completed, to include should those data change an LEA's eligibility to receive one, or more, of the four grants that comprise Title I: Basic, Concentration, Targeted or EFIG (Education Finance Incentive Grants). Title I-A eligibility requires at least 10 Adjusted Poverty Students for the LEA.

Capturing Poverty Data

When to use Free and Reduced Lunch Forms?

Free and Reduced lunch forms can be used to collect poverty data for Title I and other Federal programs when used in conjunction with Child Nutrition Programs. Use FRL forms at sites operating under the regular National School Lunch Program (NSLP).

When to use Income Eligibility Forms?

The United States Department of Agriculture (USDA) has previously released guidance that LEAs are prohibited from distributing and processing FRL applications solely to obtain household income information in order to determine the funding or benefits for programs other than the Child Nutrition Programs. Income Eligibility forms provide an alternative method of collecting the same data. Use Income Eligibility forms if your sites do not operate a CNP. Also use for sites operating under the Community Eligibility Provision (CEP) or Special Provisions Options 1/2 to collect student level data for Accountability and other programs.
