To ensure that all children receive a high-quality education, and to close the achievement gap between children meeting the challenging State academic standards and those children who are not meeting such standards, each local educational agency plan shall describe— (1) how the local educational agency will monitor students' progress in meeting the challenging State academic standards by—

(A) developing and implementing a well-rounded program of instruction to meet the academic needs of all students – ESSA Sec 1112

WELL-ROUNDED EDUCATION.—The term "well-rounded education" means courses, activities, and programming in subjects such as English, reading or language arts, writing, science, technology, engineering, mathematics, foreign languages, civics and government, economics, *arts*, history, geography, computer science, music, career and technical education, health, *physical education*, and any other subject, as determined by the State or local educational agency, with the purpose of providing all students access to an enriched curriculum and educational experience- ESSA Sec 8201

Well-Rounded Education

ESSA Statutory Language



December 10, 2015 – President Obama signs the Every Student Succeeds Act, a bipartisan bill that will help make sure every student is prepared to succeed in a 21st century economy.

- Well Rounded education appears as a student's civil right
- Over 10 different federal funding sources that could be used to fund Arts & Physical Education
- First time in our Nation's history that
 Arts and Physical Education are named in a meaningful way in Education Law.

Well-Rounded Education: A Student Civil Right

ENHANCED FLEXIBILITY: AN OPPORTUNITY TO SUPPORT STUDENT-CENTERED PROGRAMS & WELL-ROUNDED EDUCATION

- Improving access to foreign language instruction, arts, and music education
- Social emotional learning (SEL) programs and interventions
- Supporting college and career counseling, including providing information on opportunities for financial aid through the early FAFSA
- Providing programming to improve instruction and student engagement in science, technology, engineering and mathematics (STEM), including computer science, and increasing access to these subjects for underrepresented groups
- Promoting access to accelerated learning opportunities including Advanced Placement (AP) and International Baccalaureate (IB) programs, dual or concurrent enrollment programs and early college high schools for identified low-income students
- Strengthening instruction in American history, civics, economics, geography, government education, and environmental education

In general, an LEA may use funds under section 4107 for any program or activity that supports student access to and success in wellrounded educational experiences.



Arizona Administrative Code R7-2-301

Students shall demonstrate competency as defined by the State Boardadopted academic standards, at the grade levels specified (K-8), in the following required subject areas. District and charter school instructional programs shall include an ongoing assessment of student progress toward meeting the competency requirements.

These shall include the successful completion of the academic standards in at least reading, writing, mathematics, science and social studies, as determined by district and/or statewide assessments.



- 5. The Arts, which may consist of two or more of the following: visual arts, dance, theatre, music, or media arts;






